**CONDITIONS OF LICENCE**

1. The licence shall comply with the provisions of the Himachal Pradesh Agricultural and Horticulture Produce Marketing (Development and Regulation Act, 2005 (Act No. 20 of 2005), rules and bye-laws framed there under and instructions issued from time to time.
2. The licensee shall not permit evasion of fee or infringement of any of the provisions of the Act, the rules and bye-laws made there under by any trader, market functionaries using the market yard and shall report in writing to the Agricultural Produce Market Committee any evasion of fee or any infringement/ breach which comes to his knowledge.
3. The licensee shall surrender his licence on demand to the Managing Director of the Board or the Secretary of the Committee concerned against receipt to be given to the licence in this connection.
4. The licensee shall run the functioning of market yard honestly and properly according to the principles of fair dealings.

5. The licensee shall keep the premises clean and in a suitable condition for storage of agricultural produce.
6. The licensee shall not indulge in activities and practices which are detrimental to the interest of the trade and proper functioning of his market yard.
7. The licensee shall be responsible for the safe custody and protection of agricultural produce brought to his market yard for sale or storage.
8. The licensee shall not allow the exploitation of agriculturist or other producer who will be bringing his produce for sale or storage to his market yard.
9. The licensee shall levy market charges/ incidental charges as approved by the Board from time to time.
10. The licensee shall get his business premises insured against fire or other natural calamities.
11. The licensee shall maintain all those books and records which have been prescribed under these rules and submit to the authorities prescribed therein regularly.
12. The licensee shall provide all those infrastructures in the market yard which have been prescribed in the rules.
13. The licensee shall, on the expiry or sooner on the termination of the licence, surrender the same to the Board.
14. The licensee shall, when desired by the Licensing Authority or officer authorized or the Secretary of the committee concerned furnish correct information on the matters pertaining to his business/ market yard.
15. The licensee shall maintain and display daily rates and arrivals of all agricultural produce arriving in the market yard/ business place and exhibit the same in Hindi or English at a conspicuous place through trade portal network.
